We would ask you to fill in the included affidavit to keep on providing a place for our children to enjoy church in a safe and fun environment. **Please take note that in signing this you give us permission to make enquires with the relevant authorities or institutions relating to your criminal record and registers established for the protection of children. This information will be kept confidential and you indemnify the Church against any loss or liability or harm you might suffer or incur as a result of the Church accessing such records or information.**

As teachers and volunteers you will have a direct influence over the children, and your (and our) motive should at all times be to lead the child into a better understanding of God and to bring them into a deeper relationship with Jesus. With this in mind we urge you to be aware of the following things that may be a concern for you to be serving in this ministry and leading children:

1. **Darkness.** Is there any sin that you are living in that has not been brought to the light?
2. **Dependencies.** Are you currently dependent on any medication, drugs or other narcotics?
3. **Debt.** Is there currently heavy debt due to uncontrollable spending habits?
4. **Doctrine.** Is your doctrine out of line with Joshua Generation Church?

As you serve in this ministry it is very important that you remain involved:

1. As a member of Joshua Generation Church and have completed the Starting Point Course; and
2. In a community group within your congregation, and
3. In an accountable relationship with a leader in your community group or congregation.
